« Les 25 ans de l'Association européenne des anciens parlementaires des pays membres du Conseil de l'Europe : une histoire à succès ? »

Speech of Mr. Uwe Holtz, honorary President :

« 25 years of the European Association of former Members of Parliament of the Member States of the Council of Europe : a success story? »

Happy 25th anniversary, European Association of former Members of Parliament!

Dear President Rune Rydén! Madame Carole Bureau-Bonnard, Vice-President of the National Assembly! Dear colleagues, ladies and gentlemen!

I would like to begin my speech in French and to continue later on in English.

Un joyeux vingt-cinquième anniversaire à notre Association européenne !

1. Il y a un quart de siècle, le groupe de cinq associations des anciens parlementaires de la Belgique, de la France, de l'Italie, de la République fédérale d'Allemagne et de la Turquie a créé officiellement l' « Association européenne des anciens parlementaires des pays membres du Conseil de l'Europe ».
2. La « raison d'être » de notre Association réside dans : la contribution à la construction européenne et à une meilleure connaissance de ses institutions ; l'attachement aux valeurs communes, à la démocratie véritable, aux droits de l'homme et à la consolidation de la paix ; la promotion du progrès social et économique ; le soutien en faveur d'un développement durable et d'une mondialisation humaine – et l'encouragement de la compréhension mutuelle et des relations amicales.
3. L'élargissement de notre Association européenne, qui compte aujourd'hui vingt-trois associations, est une histoire à succès.

4. Les « Cinq » ont été suivis - dans l'ordre de leur adhésion – : du Chypre, des Pays-Bas, de l'Espagne, de la Grèce, de l'Irlande, du Luxembourg, de l'Autriche, de la Suisse, de la Malte, du Portugal, du Parlement Européen, de la Suède, de l'Andorre, de la Pologne, de la Lituanie, du Royaume-Uni, de la Finlande et du Norvège.
5. A l'avenir, ce succès d'élargissement devrait être prolongé.
6. D'autres pages de succès ont été écrites par les différentes activités, notamment par des colloques, séminaires et rencontres.
7. A l'égard des colloques et en particulier des déclarations pertinentes, je ne cite que quelques exemples : à Rome (2002) sur « Les valeurs européennes », à Berlin (2004) sur « L'intégration politique européenne », à Malte (2012) sur « La transition démocratique dans le sud de la Méditerranée et au Moyen-Orient », à Bruxelles (2014) sur « Les défis de la démocratie », à Lyon (2016) sur « L'immigration » et à Strasbourg (2018) sur « L'avenir de l'Europe ».
8. L'élaboration et l'adoption de toutes les déclarations (dix jusqu'à maintenant) sont des points forts de nos réflexions politiques et des actions proposées. Les associations membres sont demandées à contribuer à la 'naissance' des déclarations. Chaque déclaration est très importante pour la réaffirmation périodique de notre Association et de nous-mêmes – ainsi que la Charte européenne des anciens parlementaires (2011). Les déclarations ont parfois facilité certains engagements dans nos propres pays, dans quelques institutions européennes et dans de jeunes démocraties. Mais elles méritent une meilleure valorisation par les acteurs de la politique active et le public intéressé.

Now, I would like to switch to English

9. Member associations organized inspiring seminars on different subjects. Just a few examples:
 - In 2003, Turkey on "Turkey - a European country",
 - In 2004, Ireland on the occasion of the Irish EU presidency,
 - In 2009, Portugal on the role and status of former parliamentarians and their associations,
 - In 2015, Austria on "Seventy Years of United Nations",
 - In 2016, Sweden on "the Arctic, a hot topic",
 - In 2018, Belgium on "Europa Quo Vadis".
10. Besides the general political aims, our Association of former Parliamentarians (shortly: FP-AP) aims to develop friendly contacts and to share information with other associations. All personal contacts between our countries are important.
11. FP-AP members invited from time to time representatives to special events, in particular to associations' birthdays, e.g. Belgium, Italy and Germany. Thanks to FP-AP, Polish and German former MPs met for joint consultations.

12. Exciting meetings and lessons learned enriched the participants:

- Many of us could discover European institutions in Strasbourg, Brussels and Luxembourg.
- It was fascinating to learn something about the specific political systems in Andorra and Switzerland.
- Participants met presidents, ministers, experts, new colleagues; visited Parliaments, government buildings, town halls, institutes, museums and monuments in all the host countries of FP-AP events: in Ankara, Athens, Berlin, Bern, Kiev, Lisbon and Madeira, Lyon, Madrid and Toledo, Nicosia and Limassol, Paris, Rome, Stockholm, Valetta and Gozo, Vienna and the UN City, The Hague and Delft as well as in Warsaw, where we commemorated in June 2014 the beginning of the two World Wars.
- Colleagues could smell the flavor of united Germany in Berlin and feel the sadness about the still divided island of Cyprus.

13. All these resounding FP-AP activities could not have been realized

- without the help of the member associations – in cooperation with the FP-AP secretariat;
- not without the manifold efforts as well as political and thematic inputs by members of the Bureau and the General Assembly, by the thirteen presidents in the past 25 years and the many more vice-presidents of our Association, and by the different rapporteurs of the colloquies;
- not without the assistance of the Parliamentary Assembly of the Council of Europe, our official cooperation partner since 2009.

Mega-thanks are going to all of them!

14. Two points where there is space for improvement

- So far, women are underrepresented in the two organs of our Association. According to the FP-AP website¹, only 9 of the 23 member associations include women and just 12 of the 59 delegates nominated for the Bureau and the General Assembly by the respective associations are women. I am sure that this will change in the future. Women are *en marche!*
- The relevance of the EU is widely known and of the Council of Europe widely unknown. FP-AP helped to narrow the knowledge gap – at least among our own ranks. Walter Schwimmer, rapporteur for Europe's future, was a great facilitator in this respect, too. The pan-European house, constituted by the Council of Europe, is based on the three pillars of democracy, human rights and the rule of law and accommodates rooms with many, many conventions and treaties. Because of its potential and the contributions to European unity, the Council of Europe deserves more attention and cooperation with other entities.

18. Congratulation to the European Association on its silver jubilee!
The European Association knows that mutual understanding, cooperation and solidarity for the common good and the wellbeing of all Europeans will have to prevail over still existing disagreements, tensions and conflicts.
Let us strengthen our efforts in order to help overcome autocratic, nationalistic, racist movements and temptations. Inspired by our overarching leitmotif :
The future of Europe: never again war – never again dictatorship,
living together in peace and democracy!
All the best for the next 25 years!
